AGREEMENT FOR USE OF SERVICES  
**RAFT Resource Area for Teaching**

In consideration of access privileges to Resource Area For Teaching (RAFT) and related facilities, the undersigned agrees to comply with the following provisions:

1. RAFT receives revenues from the sale of materials to advance our mission of transforming teaching through the use of engaging hands-on educational activities. Materials purchased at RAFT may not be offered for resale or auction. RAFT honors donor wishes, and any restrictions on the use of specific materials will be noted.
  2. **For their own safety, children under the age of 12 may only enter during specified sales hours, except those recognized as volunteer assistants to RAFT.**
  3. I understand that **every person must have a personal numbered access card to access materials** available at RAFT. Only the person who is listed on the access card may use the card.
  4. Access Cards are not transferable. Transfer of use of the Access Card to another person will result in forfeiture of access privileges for that calendar year.
  5. I hereby release RAFT and any of its affiliated organizations and suppliers from all actions, claims or demands that I, my assignees, heirs, distributees, or users of materials, and legal representatives now have or may hereafter have for personal injury, death, and/or property damage resulting from my access privileges to the RAFT warehouse and related facilities. The release is intended to discharge in advance RAFT and its directors, officers, agents, managers, employees and suppliers of materials from any and all liability arising out of or connected in any way with my receipt and subsequent use of materials and/or ideas provided by RAFT, even though that liability may arise out of negligence or carelessness on the part of the persons or entity mentioned above; out of strict products liability, out of my reuse of the materials, or any other liability with or without fault.
  6. I hereby give RAFT, its agents and assigns the right to take photographs/video of me and my property while at any RAFT facility or event. I authorize RAFT and its assigns to copyright, use and publish the same in print and or electronically.
